

AUTHORIZATION TO PARTICIPATE AND RELEASE OF LIABILITY FORM

- 1. I certify that all information given on this application is accurate. If applicable, I have read and agree to abide by the California Interscholastic Federation (CIF) Student Athlete's Code of Ethics, and all student policies and procedures established by the Redondo Beach Unified School District.
- 2. I understand that many enrichment programs (including athletics) entail unknown and unanticipated risks, which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I acknowledge that such risks simply cannot be eliminated without jeopardizing the essential qualities of these activities. As a participant in this program I acknowledge that the risks may involve but are not limited to: being struck by another participant, ball, equipment, etc., or may result in contusions, sprains, fractures, broken bones or concussions.
- 3. I agree to provide proof of medical insurance with this authorization form. I agree and fully understand that the Sponsor (defined below) of the Summer Sports Camps will be liable only for any gross negligence on its part which occurs during authorized camp practices, classes, sessions, i.e., when the authorized instructor is present and supervising the enrichment event/activity.
- 4. I hereby give my consent for my daughter/son to attend the 2023 Sea Hawk Foundation Summer Sports Camp and enroll in the program(s) for which a selection has been made. I agree to ensure that my son/daughter has access to a parent or guardian (i.e., home, work or cell phone) in case of emergency, class cancellation, campus evacuation, or any other non-planned event. I agree to provide the Sponsor with valid contact information for the purposes set forth in this paragraph.
- 5. I understand and accept full financial responsibility for selection(s) made on this application. The camps are not a prerequisite for my son/daughter participating in any program or sports team offered at RUHS during the regular school year. I understand that participation in any camps is not a pre-tryout or try out for any RUHS sports team. I understand that participation in any camps does not constitute a guarantee of enrollment at RUHS for permit-seeking/out of district students. There will be no grade or credit issued for participating in the camps.
- 6. I hereby release and discharge the Redondo Beach Unified School District, Redondo Union High School, the Redondo Beach Educational Foundation and The Sea Hawk Foundation, including their trustees, officers, employees, agents, servants and volunteers (herein collectively referred to as the "Sponsor"), from any and all liability arising out of, or in connection with, the above-described camp sessions, on behalf of or for the above-named minor. For the purposes of this agreement, "liability" means all claims, demands, losses, causes of action, suits or judgments of any and every kind on account of any injury to the person or property of the above-named minor that occurs during the above-described camp sessions, and that results from any cause other than the gross negligence of the Sponsor.
- 7. Notwithstanding any insurance coverage which may be in effect, and in addition to any other undertakings referred to herein, I agree to fully indemnify, hold harmless and provide for the legal defense of Redondo Beach Unified School District, Redondo Union High School, the Redondo Beach Educational Foundation and The Sea Hawk Foundation, including their trustees, officers, employees, agents, servants and volunteers from any and all liability for injuries, deaths, damages, claims, causes of action, losses, judgments, or awards, arising out of, or in connection with, the above-described camp sessions, onbehalf of or for the above-named minor. The duty to defend, as contained in this provision, includes the payment or reimbursement of any and all attorney fees, litigation costs, claims handling expenses, and investigation fees that are incurred by or on behalf of the Sponsor.
- 8. In the event of an accident, I give permission to render emergency aid and/or to take my son/daughter to a physician or medical facility. I hereby authorize the medical staff to take all necessary actions to treat my child and I agree to assume responsibility for the cost of all such services.
